**CALL TO ORDER**

Mr. Brian Viola called the meeting to order at 7:02 p.m.

**WELCOME & INTRODUCTIONS**

Mr. Viola thanked everyone for their attendance and then introduced the Board of Directors. He highlighted that this would be the first year that the BCA Annual Meeting would be held virtually.

Mr. Viola proceeded to introduce the BCA General Manager, Mr. Rick Stone. Mr. Stone introduced himself and BCA Staff.



## **ADMINISTRATIVE MATTERS**

Mr. Stone also thanked everyone for their attendance and then briefly reviewed the agenda. There were no open seats on the BCA Board or a scheduled election at this meeting. The meeting was held in accordance with the Association's Bylaws and confirmed that the required meeting notice had been mailed via USPS First-Class mail on October 28, 2020, to 5,960 official mailing addresses on record. He announced that the required 10% quorum had been achieved by 600 developer-submitted proxies, one resident submitted paper proxy, and the meeting attendees.

## **APPROVAL OF MINUTES**

The 2019 minutes were sent to attendees prior to the meeting for review. Mr. Viola called for a final review of the minutes and a motion for approval. Mr. Chris Cook moved to approve the minutes as presented. The motion was seconded by Mr. Ram Venkatachalam and passed via acclamation.

## **BCA & BRAMBLETON GROUP PRESENTATIONS**

Presentations were pre-recorded so they could be posted on BCA's website for any residents who were unable to attend the Annual Meeting.

Mr. Stone played the 2020 BCA Highlights video that provided highlights of the Association's activities and accomplishments throughout the year, including the approval of the 2021 Budget & Assessments, as well as expectations for the upcoming year.

Mr. Stone reviewed the results of the BCA Resident Survey. The survey opened on September 23, 2020, and closed on October 20, 2020, and consisted of 16 questions. BCA received 1,479 responses, nearly a 25% response rate. Ninety-four percent of residents would recommend Brambleton as a great place to live to a friend or family member. BCA also received an average rating of 4 out of 5 stars on both Overall Satisfaction and the Association's Operations during COVID-19. Full survey results will be posted on the BCA website.

Mr. Stone introduced The Brambleton Group's video presentation showcasing Brambleton Rezonings.
